1. DEFINITIONS

Client: any natural or juristic person that received or receives services from the Company.

Company: WLMB Holdings (Pty) Ltd

Conditions for Lawful Processing: the conditions for the lawful processing of Personal Information as fully set out in chapter 3 of POPI and in paragraph 12 of this Manual.

Data Subject: the person to whom personal information relates.

Information Officer: the individual who is identified in paragraph 3 of this Manual.

Manual: this manual

PAIA: the Promotion of Access to Information Act 2 of 2000

Personal Information: means information relating to an identifiable, living, natural person, and where it is applicable, an identifiable, existing juristic person, including, but not limited to —

- a. information relating to the race, gender, sex, pregnancy, marital status, national, ethnic or social origin, colour, sexual orientation, age, physical or mental health, well-being, disability, religion, conscience, belief, culture, language and birth of the person.
- b. information relating to the education or the medical, financial, criminal or employment history of the person.
- c. any identifying number, symbol, e-mail address, physical address, telephone number, location information, online identifier or other particular assignment to the person.
- d. the biometric information of the person.
- e. the personal opinions, views or preferences of the person.
- f. correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further

correspondence that would reveal the contents of the original correspondence.

- g. the views or opinions of another individual about the person; and
- h. the name of the person if it appears with other personal information relating to the person or if the disclosure of the name itself would reveal information about the person.

Personnel: any person who works for or provides services to or on behalf of the Company, and receives or is entitled to receive remuneration and any other person who assists in carrying out or conducting the business of the Company, which includes, without limitation, directors (executive and non-executive), all permanent, temporary and part-time staff as well as contract workers.

POPI: the Protection of Personal Information Act 4 of 2013

POPI Regulations: the regulations promulgated in terms of section 112(2) of POPI.

Private Body: means—

- a. a natural person who carries or has carried on any trade, business or profession, but only in such capacity;
- b. a partnership which carries or has carried on any trade, business or profession; or
- c. any former or existing juristic person, but excludes a public body

Processing: means any operation or activity or any set of operations, whether or not by automatic means, concerning personal information, including—

- a. the collection, receipt, recording, organisation, collation, storage, updating or modification, retrieval, alteration, consultation or use;

- b. dissemination by means of transmission, distribution or making available in any other form; or
- c. merging, linking, as well as restriction, degradation, erasure or destruction of information

SAHRC: the South African Human Rights Commission

Any other terms not described herein will have the meaning as ascribed to it in terms of PAIA or POPI.

1. INTRODUCTION

- 1.1. For the purpose of POPI and PAIA, the Company is defined as a private body. In accordance with the Company's obligations in terms of POPI and PAIA, the Company has produced this manual.
- 1.2. This manual sets out all information required by both PAIA and POPI.
- 1.3. This manual also deals with how requests are to be made in terms of PAIA.
- 1.4. This manual also establishes how compliance with POPI is to be achieved.

Whenever it comes to our attention that existing or new legislation allows a Requester access on a basis other than as set out in PAIA, we shall update the list accordingly. If a Requester believes that a right of access to a record exists in terms of other legislation listed above or any other legislation, the Requester is required to indicate what legislative right the request is based on, to allow the Information Officer the opportunity of considering the request in light thereof.*

7. REQUEST PROCESS

- 7.1. An individual who wishes to place a request must comply with all the procedures laid down in PAIA.
- 7.2. The requester must complete **ANNEXURE "B"**, which is attached hereto and submit it to the Information Officer at the details specified above.
- 7.3. The prescribed form must be submitted as well as payment of a request fee and a deposit, if applicable to the information officer at the postal or physical address, fax number or electronic mail as is stated herein.
- 7.4. The prescribed form must be completed with enough particularity to enable the information officer to determine:
 - 7.4.1. The record(s) requested;
 - 7.4.2. The identity of the requestor;
 - 7.4.3. What form of access is required; and
 - 7.4.4. The Postal address or fax number of the requestor
- 7.5. The requestor must state that the records are required for the requestor to exercise or protect a right, and clearly state what the nature of the right is so to be exercised or protected. An explanation of why the records requested is required to exercise or protect the right.

- 7.6. The request for access will be dealt with within 30 days from date of receipt, unless the requestor has set out special grounds that satisfies the Information Officer that the request be dealt with sooner.
- 7.7. The period of 30 (thirty) days may be extended by not more than 30 additional days, if the request is for a large quantity of information, or the request requires a search for information held at another office of the Company and the information cannot be reasonably obtained within 30 days. The information officer will notify the requestor in writing should an extension be necessary.
- 7.8. The requestor will be informed in writing whether access to the records have been granted or denied. If the requestor requires a reason for the decision the request must be expressed in the prescribed form, the requestor must be further stated what particulars of the reasoning the requestor requires.
- 7.9. If a requestor has requested the records on another individual's behalf, the requestor must submit proof of the capacity the requestor submits the request in, to the satisfaction of the information officer.
- 7.10. Should the requestor have any difficulty with the form or the process laid out herein, the requestor should contact the Information Officer for assistance.
- 7.11. An oral request can be made to the Information Officer should the requestor be unable to complete the form due to illiteracy or a disability. The Information Officer will complete the form on behalf of the requestor and provide a copy of the form to the requestor.

8. GROUNDS FOR REFUSAL

- 8.1. The following are grounds upon which the Company may, subject to the exceptions in Chapter 4 of PAIA, refuse a request for access in accordance with Chapter 4 of PAIA:
 - 8.1.1. Mandatory protection of the privacy of a third party who is a natural person, including a deceased person, where such disclosure of Personal Information would be unreasonable.
 - 8.1.2. Mandatory protection of the commercial information of a third party, if the Records contain:
 - 8.1.2.1. Trade secrets of that third party;
 - 8.1.2.2. Financial, commercial, scientific or technical information of the third party, the disclosure of which could likely cause harm to the financial or commercial interests of that third party; and/or
 - 8.1.2.3. Information disclosed in confidence by a third party to the Company, the disclosure of which could put that third party at a disadvantage in contractual or other negotiations or prejudice the third party in commercial competition;
 - 8.1.3. Mandatory protection of confidential information of third parties if it is protected in terms of any agreement;
 - 8.1.4. Mandatory protection of the safety of individuals and the protection of property;

- 8.1.5. Mandatory protection of Records that would be regarded as privileged in legal proceedings;
- 8.1.6. Protection of the commercial information of the Company, which may include:
 - 8.1.6.1. Trade secrets;
 - 8.1.6.2. Financial/commercial, scientific or technical information, the disclosure of which could likely cause harm to the financial or commercial interests of the Company;
 - 8.1.6.3. Information which, if disclosed, could put the Company at a disadvantage in contractual or other negotiations or prejudice the Company in commercial competition; and/or
 - 8.1.6.4. Computer programs which are owned by the Company, and which are protected by copyright and intellectual property laws;
- 8.1.7. Research information of the Company or a third party, if such disclosure would place the research or the researcher at a serious disadvantage; and
- 8.1.8. Requests for Records that are clearly frivolous or vexatious, or which involve an unreasonable diversion of resources.

9. REMEDIES SHOULD A REQUEST BE REFUSED

- 9.1. The Company does not have an internal appeal procedure in light of a denial of a request, decisions made by the information officer is final.
- 9.2. The requestor may in accordance with sections 56(3) (c) and 78 of PAIA, apply to a court for relief within 180 days of notification of the decision for appropriate relief.

- 10.7. The following Security measures are implemented by the Company:
- 10.8. The Company implements numerous Security measures to protect personal information that is stored electronically and physically.
 - 10.8.1.1. the Company ensures that appropriate security measures are taken and updates these measures on a regular basis.
 - 10.8.1.2. the Company have also implemented various policies for additional security for personal information stored both physically and electronically.
 - 10.8.2. The personal information that is stored physically is protected as follows:
 - 10.8.2.1. Where physical records of the data exist, such records will be stored in a secure area that can be 'locked-away' as to avoid a breach of the personal information.
 - 10.8.2.2. Such physical data records will be 'locked-away' and secured when not in use.
- 10.9. The Company may share personal information with third parties and in certain instances this may result in cross border flow of the personal information. The personal information will always be subject to protection, not less than the protection it is afforded under POPI.
- 10.10. Objection to the processing of personal information by a data subject:
 - 10.10.1. Section 11(3) of POPI and regulation 2 of the POPI regulations provides that a data subject may, at any time object to the processing of their personal information in the prescribed form attached to this manual as **ANNEXURE "C"**.
- 10.11. Request for correction or deletion of personal information:
 - 10.11.1. Section 24 of POPI and regulation 3 of the POPI regulations provides that a data subject may request for their personal information to be corrected and/or deleted in the prescribed form attached hereto as **ANNEXURE "D"**.
 - 10.11.2. Regulation 8 of the POPI regulations provides for requests the outcomes of requests and of fees payable in the prescribed form attached hereto as **ANNEXURE "E"**.
